Head Lifeguard Seasonal Position

GENERAL FUNCTION

A Head Lifeguard employed with the City of Port Washington Parks and Recreation Department is responsible for the efficient and effective operation of the Pirates' Hollow Waterpark and associated aquatics programs. This position is also responsible for the health, safety, and welfare of those using the swimming pool. This position is under the supervision of the Parks and Recreation Supervisor. The Head Lifeguard is responsible for following and carrying out all of the workplace expectations and policies of the Pirates' Hollow Waterpark.

SPECIFIC JOB RESPONSIBILITIES

Supervise the activities of pool staff and patrons by enforcing rules and regulations

Train, schedule and supervise all pool staff

Plan, organize and promote aquatic programs/activities (swim lessons, pool parties, etc.)

Rescue persons in distress or in danger of drowning when indicated and provide rescue breathing, CPR, and First Aid

Notify the Parks and Recreation Department of any accidents, rescues, or problems that have occurred

Perform duties of swim instructor, lifeguard and recreation aide

Maintain and complete accurate records of pool operations, including time sheets, daily reports, accidents, incidents, attendance, finances, and required records for Health Department

Inventory and recommend for purchase all necessary supplies and equipment

Coordinate with Recreation Supervisor for the purchase of items for concession area

Oversee the general custodial cleaning of entire pool facility including vacuuming, hosing of decks, cleaning filters and restrooms, etc. as needed

Conduct pH and chlorine tests and record in log book

Plan and schedule in service training for lifeguards including first aid skills, facility maintenance, emergency procedures and other applicable information

Assist staff and public in a professional and courteous manner

Any other additional duties required

QUALIFICATIONS

Currently certified with Red Cross Lifeguard Training

Current Red Cross or First Aid and CPR/FBR cards

Lifeguarded for 2 seasons at Pirates' Hollow Waterpark

Employed at Pirates' Hollow Waterpark for 3 seasons

Lifeguard Instructor Certified

SKILLS

The Head Lifeguard must have knowledge of water hazards, lifesaving techniques and first aid, recognize hazardous situations and apply effective courses of action. This position also requires effective communication, both written and verbal, and has the ability to engage positively with staff and the public.

PHYSICAL SKILLS

While performing the duties of this position, the employee is frequently required to sit, kneel, stand, communicate, reach and manipulate objects. The position requires mobility. Duties require attentiveness to visual and audible cues for recognition and identification of swimmers in distress or in process of unsafe behaviors. This position requires proficient swimming ability and the proper application of rescue and first aid techniques. The position requires the ability to properly extract victims from the pool to the deck. The position requires working outside in warm temperatures (June through August).
